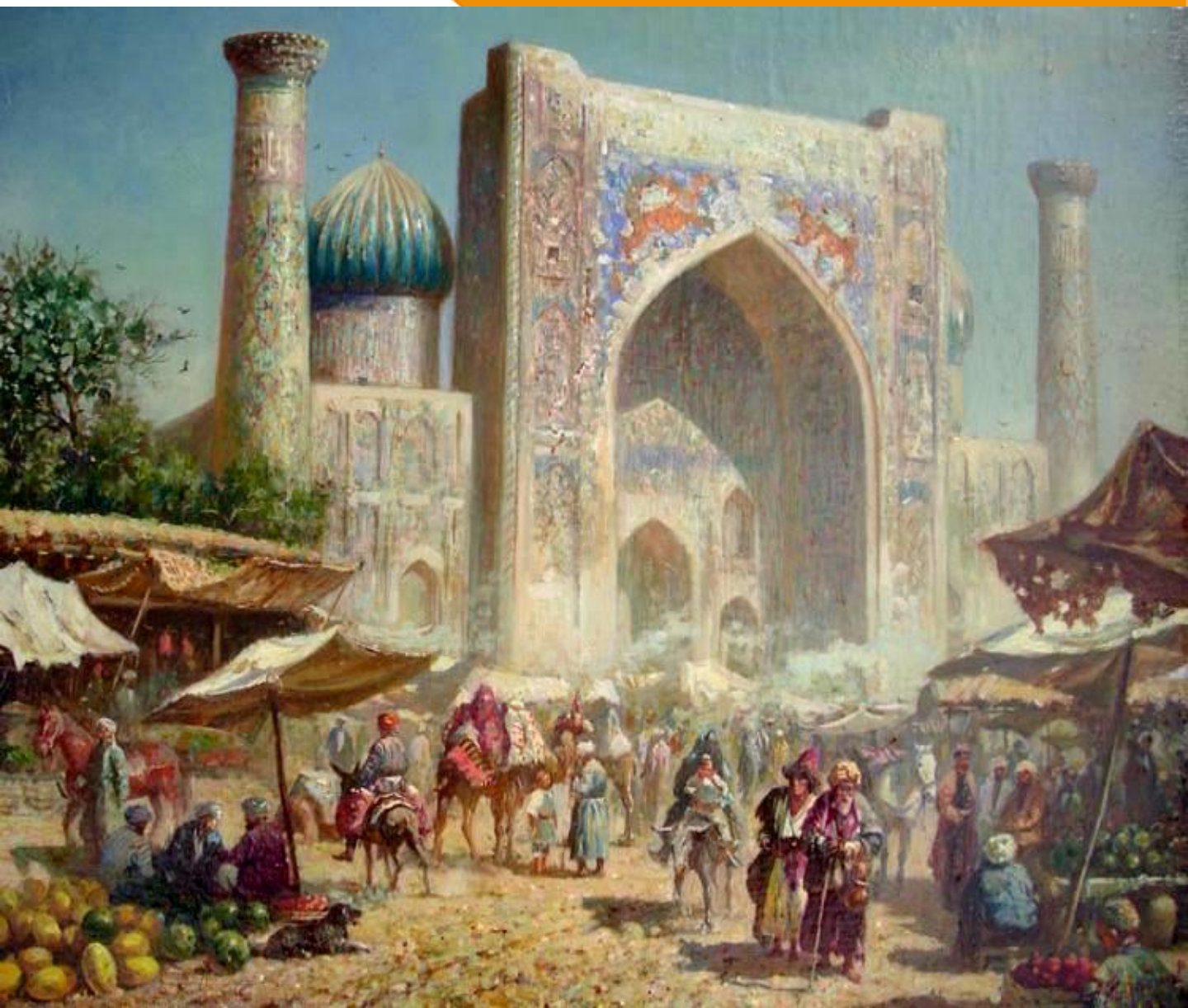




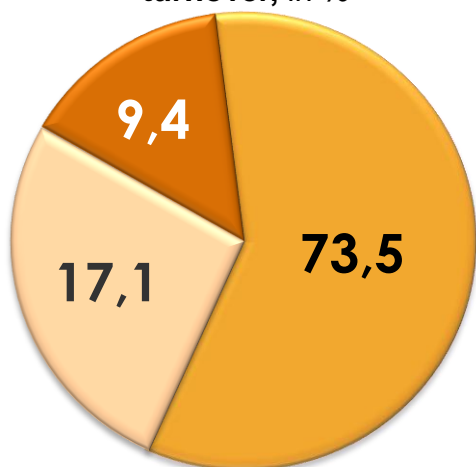
RETAIL AND WHOLESALE TRADE TURNOVER IN THE REPUBLIC OF UZBEKISTAN

*(preliminary data
for January-February 2021)*



The retail trade turnover in January-February 2021 reached **28 688.7** billion soums and increased, compared to the same period in 2020, by **0.7%**, also the turnover of large enterprises amounted to **4 912.5** billion soums (growth rates - **112.6%**), and small business and private entrepreneurship – **21 080.0** billion soums (growth rates - **98.4%**), including unorganized trade amounted to **2 696.2** billion soums (growth rates – **100.3%**).

Structure of retail trade turnover, in %



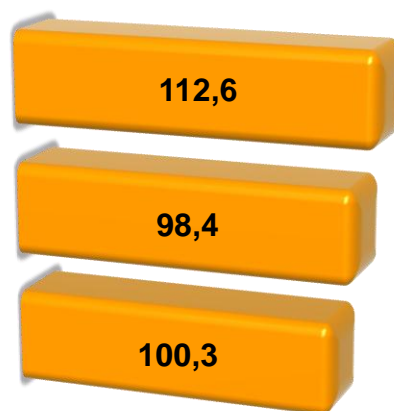

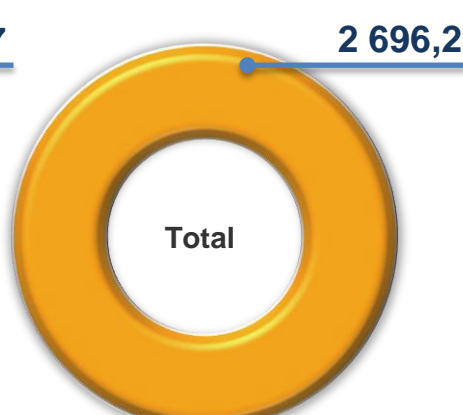

General information

SMALLEST SHARE OF REGIONS

In the structure of retail trade turnover in the period under review, the smallest share was recorded at **1.7%**, or **486.5** billion soums, which was noted in Syrdarya region in January-February 2021.

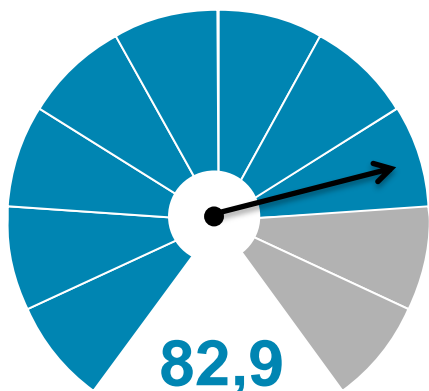

The turnover of retail trade of small business and private entrepreneurship, according to statistical calculations, amounted to **23 776.2** billion soums and, compared to the same period in 2020, decreased by **1.4%**. The share of this sector in the republic in the retail trade turnover reached **82.9%**.

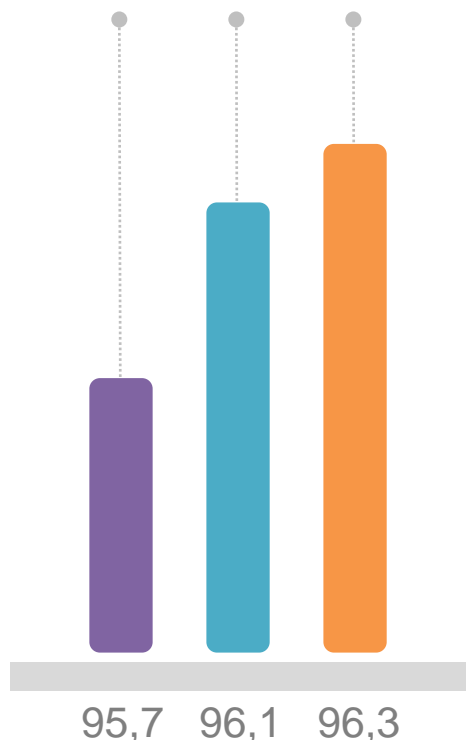

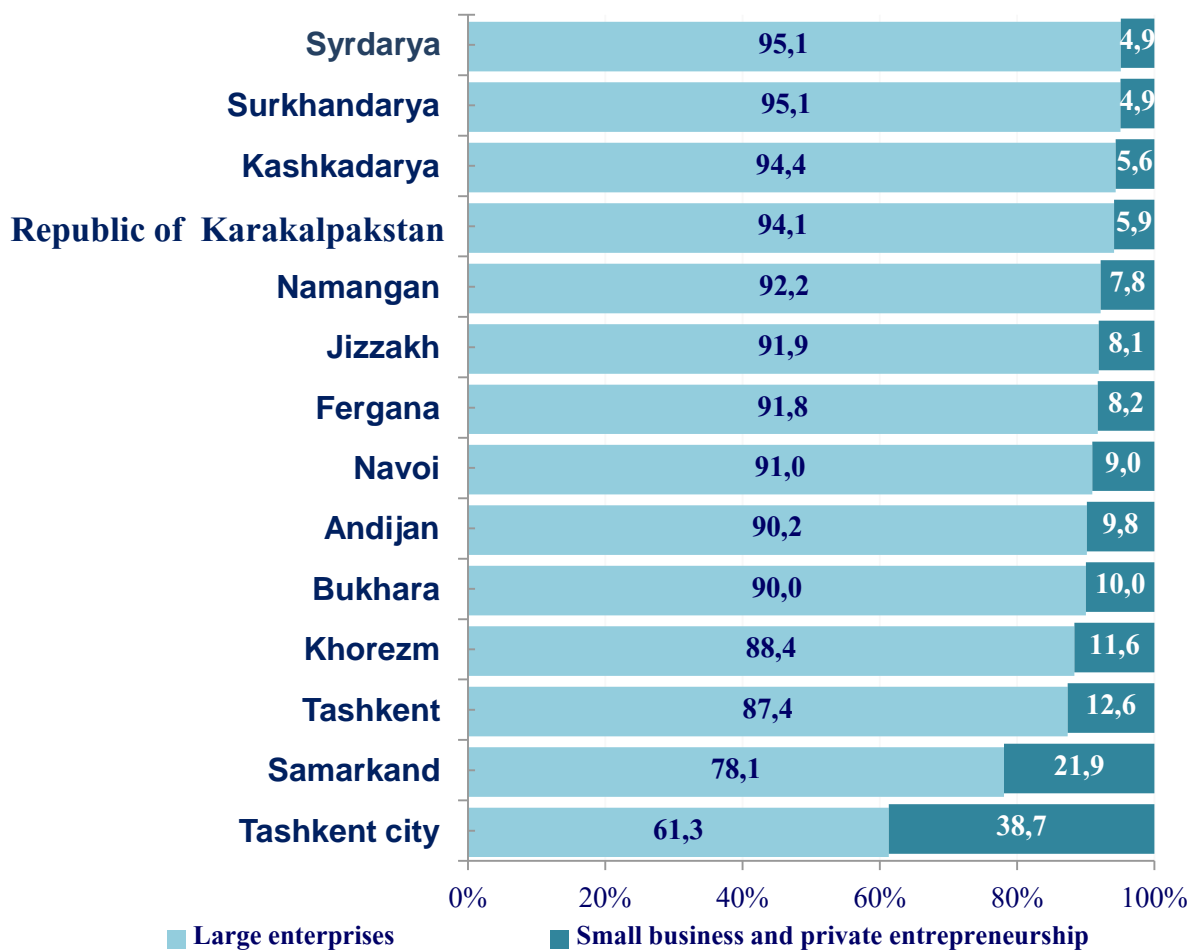

SHARE OF LARGE ENTERPRISES, SMALL BUSINESSES AND PRIVATE ENTREPRENEURSHIP IN RETAIL TRADE, in%

The share of small business and private entrepreneurship, in comparison with other regions, was the largest in Syrdarya (**95.1%**), Surkhandarya (**95.1%**), Kashkadarya (**94.4%**) regions and the Republic of Karakalpakstan (**94.1%**). In the structure of retail trade turnover, the share of turnover of large enterprises amounted to **17.1%** of the total sales, their main share was observed in Tashkent city (**38.7%**), Samarkand (**21.9%**), Tashkent (**12.6%**) and Khorezm (**11.6%**) regions.

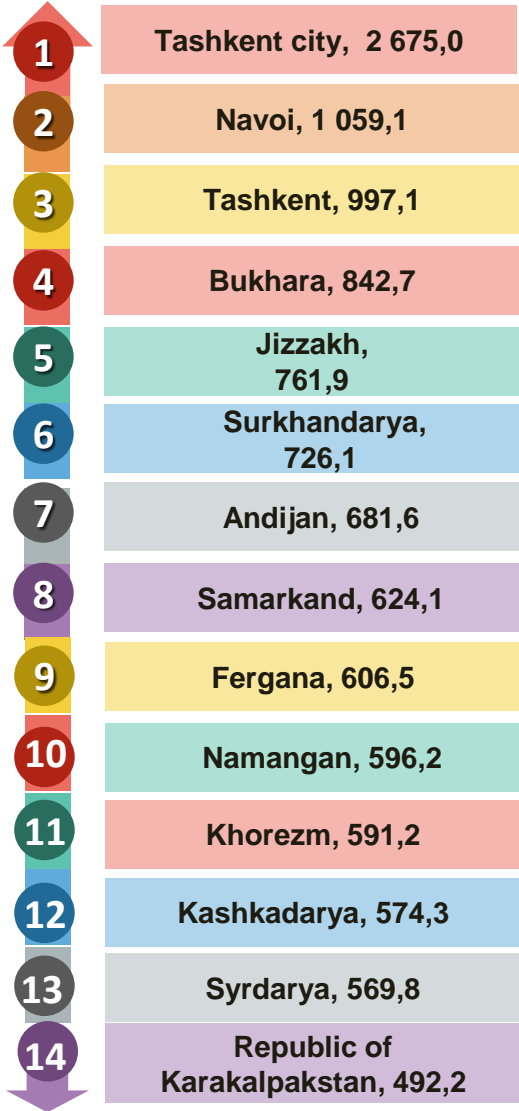


VOLUME AND RATE OF GROWTH PER CAPITA IN RETAIL TRADE TURNOVER

The retail turnover per capita in the republic in January-February 2021 averaged **838.1** thousand soums (compared to the same period in 2020, it decreased by **1.2%**).

This indicator, in comparison with other regions, was more recorded in Tashkent city (**2 675.1** thousand soums), Navoi (**1 059.1** thousand soums) and Tashkent (**997.2** thousand soums) regions.

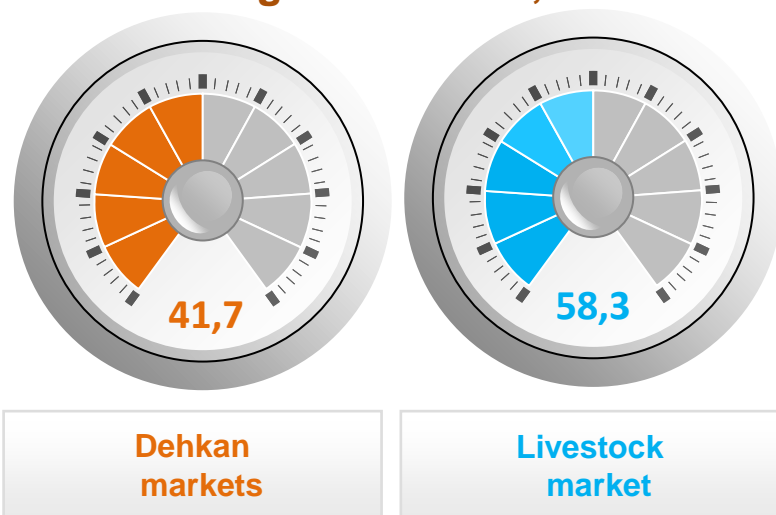

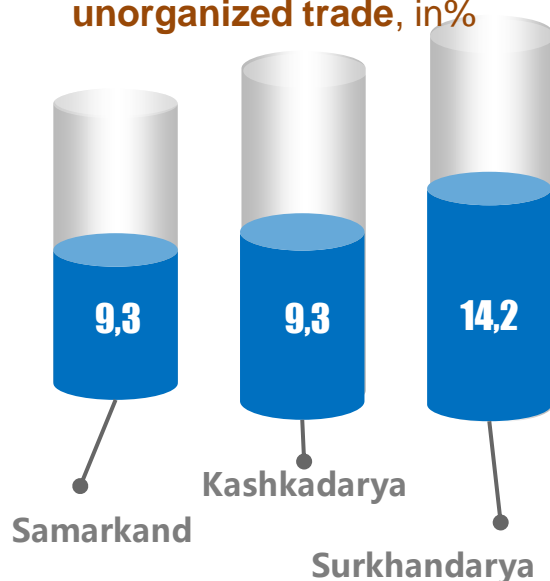
Informal trade turnover

According to preliminary data from a survey of individuals, the turnover of unorganized trade in January-February 2021 amounted to **2 696.2** billion soums and, compared to the same period in 2020, increased by **0.8%**. Including trade turnover in dehkan markets amounted to **1 125.5** billion soums (a decrease of **2,7%**), trade turnover in livestock markets was recorded at the level of **1 570.7** billion soums (growth rate of **98.7%**).

According to preliminary data from a survey of individuals involved in the sale of agricultural products, poultry and livestock (grown and kept in personal subsidiary plots), conducted in January-February 2021, trade turnover in dekhkan markets amounted to **1 125.5** billion soums, livestock markets - **1 570.7** billion soums.

TURNOVER OF UNORGANIZED TRADE : DEHKAN MARKETS

In January-February 2021, a survey of individuals engaged in the sale of agricultural products (grown on personal subsidiary plots) was carried out in all regions of the republic, as a result of which the turnover of this type of trade amounted to **1 125.0** billion soums. High sales of fresh agricultural products reached **390.5** billion soums.



NON-ORGANIZED TRADE TURNOVER: CATTLE MARKETS

In January-February 2021, a survey of individuals involved in the sale of poultry and livestock (kept in personal subsidiary plots) was carried out in all regions of the republic, as a result of which the turnover of this type of trade amounted to **1 570.7 billion soums**. The sale of livestock of different ages reached **1 176.4 billion soums**, sheep and goats – **312.9 billion soums**, horses – **70.5 billion soums**, birds – **10.9 billion soums**..



VOLUME AND GROWTH RATES OF LARGE ENTERPRISES, SMALL BUSINESSES AND PRIVATE ENTREPRENEURSHIP IN THE TURNOVER OF CATERING ENTERPRISES

In January-February 2021, the share of trade turnover of public catering enterprises in the structure of retail trade turnover amounted to **3.0%**, reaching **858.4** billion soums, and increased by **1.9%** compared to the same period in 2020. Of these, **81.1%** of the trade turnover falls on the share of small businesses.

The turnover of public catering in the period under review amounted to **858.4** billion soums (by January-February 2020 - **101.4%**), by forms of ownership: non-state - **855.8** billion soums and state - **2.6** billion soums.

Compared to the same period last year, the turnover of public catering enterprises of state ownership decreased from **4.3%** to **0.3%**.

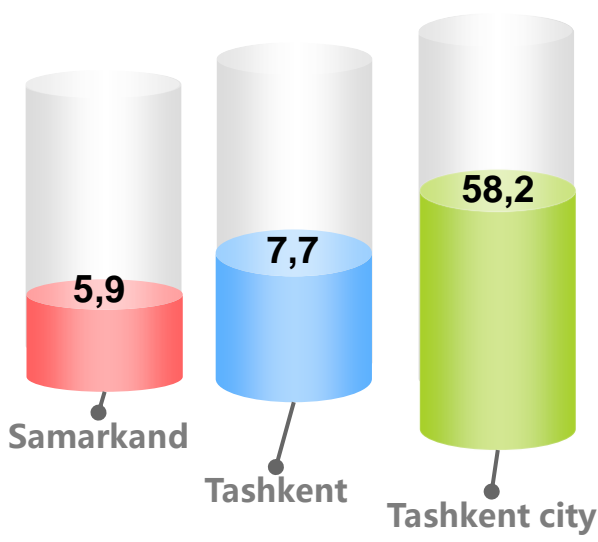
WHOLESALE TRADE

According to preliminary data, in January-February 2021, the volume of wholesale trade reached **13 583.0** billion soums and, compared to the same period in 2020, increased by **8.7%**. The turnover of wholesale trade of large business entities, according to statistical calculations, amounted to **4 694.9** billion soums and, compared to the same period in 2020, increased by **39.4%**. The share of this sector in the wholesale trade turnover in the republic amounted to **34.6%**.

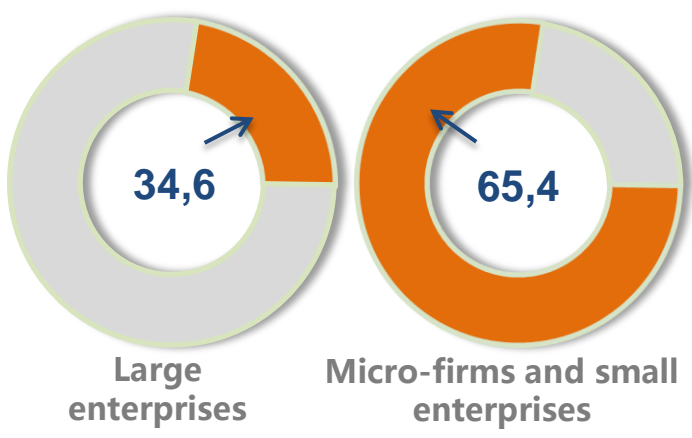
Share and volume of trade turnover

VOLUME AND RATES OF GROWTH OF LARGE ENTERPRISES AND SMALL BUSINESSES IN WHOLESALE TRADE

The highest growth rates of the wholesale turnover of large enterprises, compared to the same period in 2020, were noted in Bukhara (**136.4%**) region, Tashkent city (**124.8%**) and Kashkadarya (**113.8%**) region.

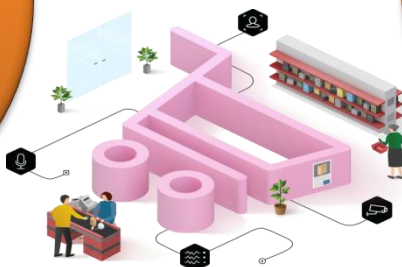
WHOLESALE TRADE TURNOVER BY FORMS OF OWNERSHIP

In recent years, the role of the public sector in the total volume of wholesale trade has been steadily decreasing. Thus, for the reporting period, the share of this sector was fixed at the level of **0.1%** of the total volume of wholesale trade. Wholesale trade turnover in January-February 2021 amounted to **13 583.0** billion soums, including entities of non-state subordination - **13 569.4** billion soums, state subordination - **13.6** billion soums.

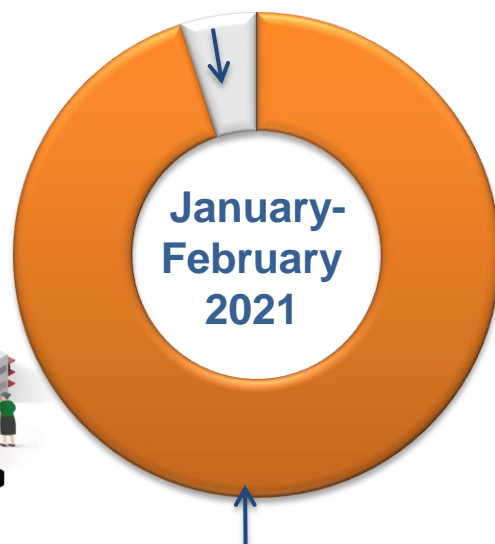
State ownership, 0,1 %

Анализ Analysis of the share of wholesale trade by type of ownership showed that there is still an insignificant share of state ownership in the city of Tashkent (0.04%), Navoi (0.02%), Andijan (0.01%) regions. In other regions, wholesale trade is generally a non-state form of ownership.
