

The attention paid to entrepreneurship in our country in recent years

Entrepreneurs are an important driver of economic development, employment, and income growth. In recent years a number of decrees and resolutions of the President of our country have been adopted in order to provide comprehensive support to this industry.

In particular, the procedure for state registration of business activities, obtaining permits and many other services has been simplified. For the convenience of the population, the civil service Agency and its local centers were created, and the position of an authorized representative (business Ombudsman) for the protection of the rights and legitimate interests of business entities was introduced.

Prime Minister's offices have been set up in all regions of the country to assist in receiving and resolving business complaints. The state Fund for business development was established under the Cabinet of Ministers of the Republic of Uzbekistan. The volume of loans issued by commercial banks to entrepreneurs has increased.

In recent years, the number of operating and newly created enterprises and organizations has increased due to the favorable conditions created by the government for the further development and sustainability of business activities.

Information on enterprises and organizations was compiled on the basis of the database of the State Services Agency under the Ministry of Justice of the Republic of Uzbekistan as of October 1, 2020 (excluding farms and dehkan farms).


Number of operating enterprises and organizations

(as of October 1, thousand units and growth rates compared to the previous year)




Number of operating commercial enterprises

(according to the classification of organizational and legal forms as of October 1, 2020, units




Number of operating enterprises and organizations

The total number of operating enterprises, compared with the same period last year, increased by 36,9 %














Number of operating enterprises and organizations in the industrial sector

The total number of operating enterprises, compared to the same period last year, increased by 16,6 %
















As of October 1, 2020, the number of industrial enterprises and organizations amounted to 80.0 thousand units. and an increase over the same period last year reached 116.6%.


The main factor in the growth of the number of industrial enterprises and increase organizations the was in production in the manufacturing industry - by 116.8% (the share of the total number is 94.7%), in the mining industry and quarrying - 113.5% (the share of their total number reached 3.2%), electricity, gas, steam and air conditioning - 127.8% (their share of the total amount is 0.6%) and water supply, sewerage, waste collection and disposal - 106.9% (their share of the total amount is 1.5%).





Number of operating enterprises with foreign capital



As of October 1, 2020, the number of enterprises and organizations in the construction sector amounted to 39.9 thousand units and, compared to the same period last year, it increased by 111.7%. The main factor in the growth in the number of construction enterprises and organizations was the increase in specialized works - by 106.3% (the share of the total number is 58.0%), in the construction of civilian objects, the number of enterprises and organizations increased by 121.2% (the share of their total number is 9.4%), the construction of buildings and structures - by 119.6% (the share of their total number reached 32.6%).


Number of operating enterprises and organizations in the field of trade

As of October 1, 2020, the number of enterprises and organizations in the trade sector amounted to 124.1 thousand units. and, compared to the same period last year, increased by 130.1%.

The main factor in the growth in the number of trade enterprises and organizations was retail trade, except for the trade in cars and motorcycles, which increased by 133.9% (their share of the total number is 63.3%), wholesale trade, except for trade in cars and motorcycles, increased by 121.1% (the share of their total number is 28.5%), wholesale and retail trade in cars and motorcycles and their repair, compared with the previous year, increased by 134.6% (the share of their total number is 8.2%).





Number of operating enterprises and organizations in the field of trade








(as of October 2020, units)




As of October 1, 2020, the number of enterprises and organizations in the field of accommodation and catering services amounted to 28.6 thousand units and increased, compared to the same period last year, by 116.5%.

The main factor in the increase in the number of enterprises and organizations in the field of general housing and catering services is the provision of food and drinks by 116.0% (their share of the total number is 90.7%), accommodation services increased by 121.2% (the share of their total number reached 9.3%).










Number of operating enterprises with foreign capital






Number of operating small enterprises and micro-firms

As of October 1, 2020, the number of registered family businesses amounted to 42.5 thousand units, which is 17.4 thousand units, or 169.1% more than in the same period last year.

The number of operating family enterprises is 39.6 thousand units, which is 15.4 thousand units, or 163.9% more than in the same period last year.

The number of newly established family businesses in January-September 2020 amounted to 14.2 thousand units, which is 4.9 thousand units, or 152.3% more than in the same period last year.

Number of limited liability companies

(as of October 1, units)

As of October 1, 2020, the number of registered limited liability companies reached 272.9 thousand units and, compared to the same period last year, the increase was 52.8 thousand units, or 124.0%.

Operating enterprises account for 258.3 thousand units and, compared to the same period last year, their number reached 47.3 thousand units, or 122.4%.

In January-September 2020, the number of newly created limited liability companies amounted to 45.7 thousand units, which is 2.1 thousand units, or 4.4% less than in the same period last year.






As of October 1, 2020, the number of enterprises with the participation of foreign capital amounted to 11.9 thousand units, of which 11.3 thousand units, or 95.2%, are operating. This indicator, in comparison with the same period last year, increased by 1.8 thousand units, or 118.1%.

In January-September 2020, 1 237 units were created in our republic enterprises with foreign capital participation.



The largest number of operating enterprises with foreign capital reached in the city of Tashkent – 6 650 (58.7% of their total number), 1 281 - Tashkent (11.3%) and 557 - Samarkand regions (4.9%). The smallest number of them is found in Khorezm - 162 (1.4%), Kashkadarya - 210 (1.9%), Syrdarya - 182 (1.6%) regions and the Republic of Karakalpakstan - 164 (1.4%).

(as of October 1, 2020, units)



The number of newly created enterprises and organizations by region





(as of October 1, 2020, units)





Number of operating limited liability companies by region




Distribution of enterprises with foreign capital (joint and foreign) by region



Explanation of statistical indicators

The Unified State Register of Enterprises and Organizations is an automated system containing periodically updated information of a reference character, which provides state accounting and identification of enterprises and organizations based on a unified classification system.


Registered enterprises and organizations are legal entities that have passed state registration in the established body in the prescribed manner and have the status of legal entities in the state register (with the exception of liquidated legal entities).

Operating enterprises and organizations are legal entities that have undergone state registration in the registering body in accordance with the established procedure and have not submitted information to the state statistics bodies about the failure to carry out or terminate financial and economic activities.

Newly created enterprises and organizations are legal entities that have undergone state registration in the registering body in accordance with the established procedure and entered (re-included) in the state register of legal entities.

Small enterprises and microfirms are organizations related to small businesses in accordance with Appendix 1 to the Resolution of the Cabinet of Ministers of the Republic of Uzbekistan dated August 24, 2016 No. 275 "On measures to transfer to the international system of classification of types of economic activity".
